


# Working in partnership to tackle economic inactivity in Mansfield...

### Talking transport opportunities...

I've been in Birmingham talking transport with Midlands Connect and colleagues from Local Government, DfT, Network Rail and others.

We spoke about the changes in rail investment following recent Government announcements, the new funding we received a few weeks ago to improve buses from 2024/5, and the expectation for roads funding to come in the weeks ahead.

Meanwhile, £1.5bn of new devolved transport funding for the East Midlands, through our new regional Combined Authority plans, alongside that newly announced roads and bus funding from central government gives us a chance to be positive and aspirational for the future of our public transport network.




## **Removing Burdensome EU Regulations**

As you may be aware, the Retained EU Law (REUL) Reform programme is underway and significant progress has been made in the time since the REUL Act received Royal Assent. A number of Statutory Instruments (SIs - pieces of minor legislation) have been

laid using the REUL Act powers, which can be found alongside their explanatory memoranda at **REUL (Revocation and Reform) Act 2023 statutory instruments - GOV.UK (www.gov.uk)** with more reforms due to follow next year. These include two significant REUL Act SIs relating to equality and employment law, which were laid on Tuesday.

The REUL Act enables us to remove unnecessary, burdensome, or otherwise unwanted regulations which encumber businesses and no longer meet the Government's policy objectives. This is an important part of the Government's wider Smarter Regulation programme which is working to improve and update how the UK is regulated.

The Government has made significant progress in the time since the REUL Act received Royal Assent and a number of SIs have been laid using the REUL Act powers. The Government has reformed or revoked over 1,000 pieces of retained EU law. By the end of this year another 600 pieces of REUL will have been revoked, whilst the Financial Services and Markets Act and the Procurement Bill will repeal around 500 further pieces of REUL. This means more than 2,000 revocations and reforms are already completed or under way in total.

## Millions of funding for local skills training!

Fantastic news that our area will receive millions more funding focused on developing skills and training in our area, and particularly to build on exciting new projects and investments coming our way in sectors like renewables and clean energy, construction, or digital industries.

This will be channelled through the new Combined Authority for Derbyshire and Nottinghamshire, and for the first time we'll have local control over our strategy for developing this work rather than it being 'done to us' by Whitehall.

## Considering listing only ONE school?

**Robin** lives in the catchment area of a popular primary school.

- Parent applies on time listing 1 preference for an out of catchment school
- On National Offer Day, the preferred school is oversubscribed (more applications than places available) and a place cannot be offered for Robin
- A place cannot be offered at the catchment school as it is also oversubscribed with preferences
- Robin is offered a place at a school over 6 miles away the next closest with places available



### **Primary School Applications!**

If your child turns 5 between 1 Sept 2024 and 31 Aug 2025, or transfers from infant to junior school, you will be able to apply for their September 2024 school place. This advice might seem obvious, in the scenario above, but every year some families end up missing out because they don't use all of their preferences on the form. Please do follow the advice and list multiple schools. Listing just one option will not guarantee you get that school, it will just mean that you could end up absolutely anywhere if you don't get your first choice.


